- The AGRC does not agree to arbitrate claims as set forth on the official AKC entry form for these events.
- Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- Owners are responsible for errors in making out entry forms, whoever may make such errors and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
- No dogs wrongly entered in a class may be transferred to another class except as provided for in Chapter 11, Section 6 of the AKC Rules Applying to Dog Shows "a correction may be made in the sex of a dog, or a dog may be transferred from one division of the Puppy Class prior to judging, and except that dogs which according to their owner's records have completed the requirements for a Championship after the closing of entries for a show, but whose Championships are unconfirmed, may be transferred from one of the regular classes to Best of Breed competition, provided this transfer is made by the Superintendent at least one half hour prior to the scheduled start of any regular conformation judging at the show." Or Chapter 1, Section 16 of the AKC Obedience Regulations.
- All trophies must be claimed the day of the show. None will be mailed. The club reserves the right to substitute a prize of equal or greater value. All prizes offered by the Atlanta Golden Retriever Club are through the generosity of its members, friends and by the club.
- ***Obedience and Rally Trials – Obedience Entries are limited not to exceed 8 hours per judge per trial for Golden Retrievers, All Breeds & All-American Dogs with Golden Retrievers receiving first priority.***
