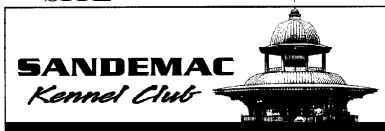

DIRECTIONS TO THE SHOW VETERINARIANS OFFICES

NORTHGATE PET CLINIC: Exit the Main Gate of the Fairgrounds, turn left onto Sangamon Avenue, and go to Interstate 55 South. Follow 55 S to Interstate 72 to Decatur, IL, exit 51 South to Pershing Road, turn left, continue to Martin Luther King Jr. Drive (Ford Dealership on right), turn right, continue one block, Northgate Pet Clinic is on the left. (Approximately 40 miles).

ANIMAL EMERGENCY CLINIC: Exit the Main Gate of the Fairgrounds, turn right onto Sangamon Avenue, and go to Fifth St. Turn right onto Fifth St. to the traffic light at Browning Rd. and turn left. Take Browning Rd. to the first traffic light (Veterans Parkway) and turn left. Take Veterans Parkway 6.8 miles to Wabash Ave. (just past White Oaks Mall), turn left. Take Wabash Ave. 2 miles. The Animal Emergency Clinic is on the left hand side of the road.

The Sandemac Kennel Club, the Champaign Illinois Kennel Club & the Mattoon Kennel Club, Inc. retain all rights to photograph or videotape by any means, and televiser or reproduce these events in any way, now and in the future.

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule printed in this program. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show-giving Club and Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Being an unbenched show, you need to be at show only in time for your judging and may leave any time after judging. Numbers before each Breed represent the number of dogs entered in (1) the regular dog classes; (2) regular bitch classes; (3) Specials Only, Best of Breed or Best of Variety Competition; and in (4) Non-Regular classes.

ATTENTION EXHIBITORS

The Show Site Building will be available to exhibitors after 2:00 PM Thursday. Dogs must be removed from the show site immediately following Best in Show judging of the Mattoon Kennel Club, Inc. show on Sunday. Exhibitors should be advised of the following rules. Any failure to comply with these rules will result in charges brought before the Event Committee.

- **WE ENCOURAGE ALL EXHIBITORS NOT TO LEAVE DOGS IN THE BUILDING OVERNIGHT. IF LEFT, CONTACT INFORMATION SHOULD BE LEFT WITH NIGHT SECURITY. THE EXPO BUILDING WILL BE LOCKED AT 10:00 PM AND OPENS AT 6:00 AM DAILY.**
- **The Central Illinois Cluster does not encourage saving space. In any case, where too much space has been saved and such space is needed for other exhibitor's grooming, the Cluster Committee or Show Chairs will condense grooming spaces to accommodate all exhibitors.**
- No private exercise pens allowed inside the Show Building at any time. This includes cocker & puppy pens. The Event Committee retains the right to designate what constitutes exercise pens & crates. Outside exercise pens only in designated area.

RV parking for the Central Illinois Classic will be in the **Carnival Midway** area along the south curve of the race track.

ELECTRICAL HOOKUPS are limited to **30 amps**. These are GFI (ground fault interrupter) circuits. If your unit will not operate on GFI, please notify us. If you require **50 amps**, please utilize our permanent campground located in the southwest corner of the fairgrounds just inside Gate 11. **ELECTRICAL HOOKUPS** are limited to one connection per camping unit.

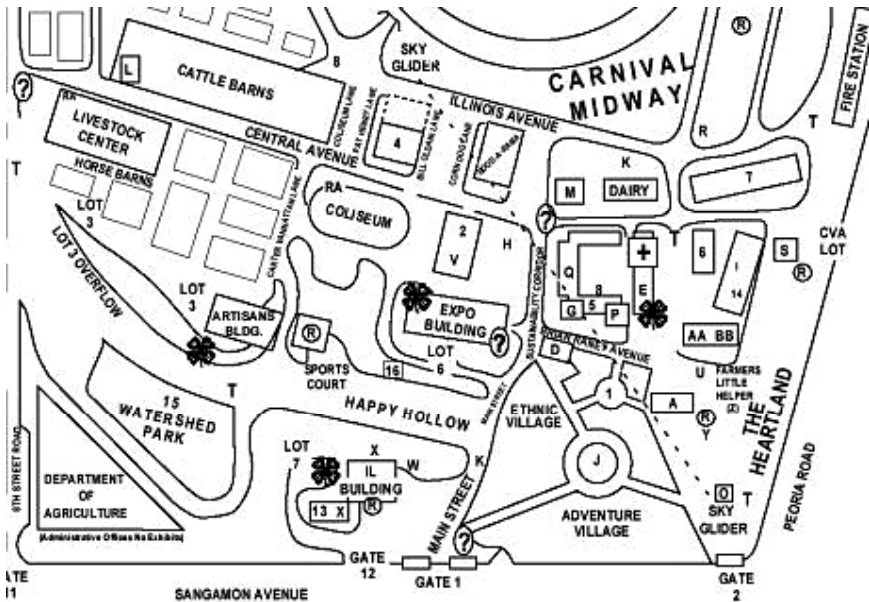

If an **AFTER HOURS** call-out is required for the electrical shop, and the cause is due to system failure, there will be no charge. If the call is necessitated by negligence or failure to follow campground requirements, **the responsible individual will be billed at prevailing labor rates.**

You must display your camping permit in the windshield or other highly visible location of your camper while you are attending your event. Otherwise, your camper may be tagged as not permitted and subject to tow at owner's expense.
