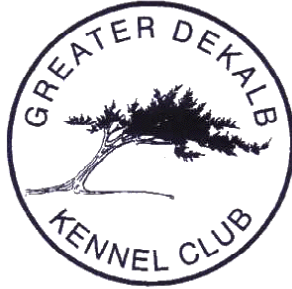

Being an unbench show, you need to be at show only in time for your judging and may leave any time after judging. 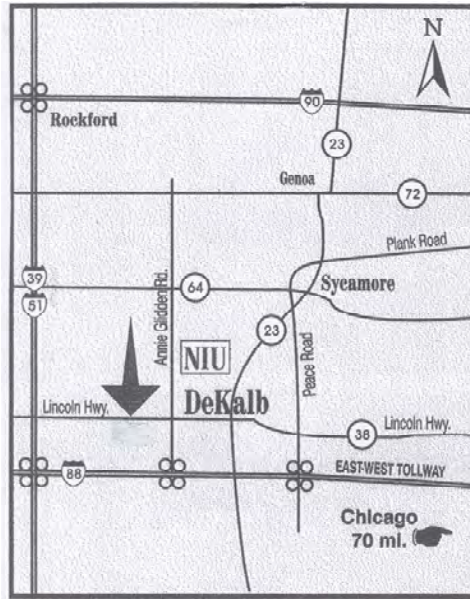
