**ENTRY FEE:** \$35.00 for the first entry of each dog except Puppies (6-9 & 9-12 mos) Classes, which are \$25.00 (including 50¢ AKC recording fee & \$3.00 A.K.C. Event Service Fee) and \$25.00 for each additional entry of the same dog. See Page 4 for entry fees.

**CLOSING DATE** for entries 12:00 Noon, Wednesday, September 4, 2019 (at Superintendent's Office) after which entries cannot be accepted, cancelled or substituted except as provided for in Chapter 14, Section 6 of the Dog Show Rules.

**THE SHOW, OBEDIENCE & RALLY TRIAL** Show Hours will be 6:00 AM to 9:00 PM.
