**DIRECTIONS TO BETHANY ANIMAL HOSPITAL:** Depart Convocation Center to SR 38  
exit. Turn left (East) onto SR 38 (W. Lincoln Hwy.). Go approx 1.6 miles, turn left (North)  
onto SR 23 (N. 4th Street). Go 3.1 miles, turn left (West) onto Bethany Road. Go to 2400  
Bethany Road, Sycamore, IL 60178. (Driving time is 11 minutes.)

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule printed in this program. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show-giving Club and Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Being an unbenched show, you need to be at show only in time for your judging and may leave any time after judging. Numbers before each Breed represent the number of dogs entered in (1) the regular dog classes; (2) regular bitch classes; (3) Specials Only, Best of Breed or Best of Variety Competition; and in (4) Non-Regular classes.

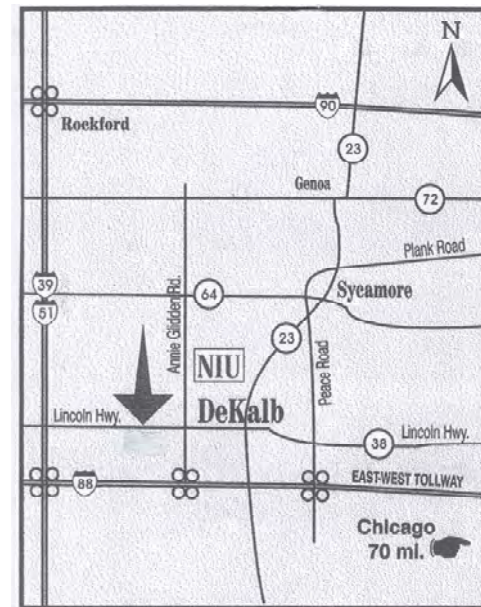
