EXHIBITORS PLEASE NOTE

Exhibitors should follow their Veterinarians' recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

"Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment."

No dogs that are disqualified for aggression will be allowed to enter these Shows, nor be allowed to be on the grounds. In addition, no aggression reinstatement procedures will be performed at these Shows.

ATTENTION OWNERS/EXHIBITORS OF FOREIGN REGISTERED DOGS
