Directions to North Central Veterinary Center: from Lake County Fairgrounds go North on Court Street to Main street and proceed north around the Crown Point Courthouse.

Proceed North as Main Street turns into Route 55. Take Route 55 North to US Hwy 30. At Hwy 30 turn Left and proceed to Indianapolis Blvd. Turn right(north) on Indianapolis Blvd to Ridge Road. Turn right (east) onto Ridge Road for one block and you have reached your destination.

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule printed in this program. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show-giving Club and Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Being an unbenched show, you need to be at show only in time for your judging and may leave any time after judging. Numbers before each Breed represent the number of dogs entered in (1) the regular dog classes; (2) regular bitch classes; (3) Specials Only, Best of Breed or Best of Variety Competition; and in (4) Non-Regular classes.

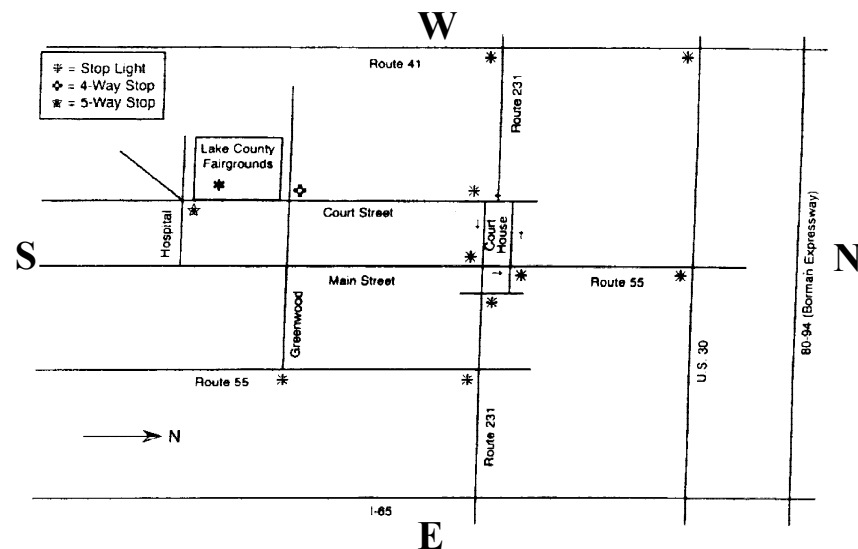
