In order to comply with the provisions of Wisconsin Statutes [s. 95.21 (2)] and Administrative Codes [s. ATCP 11.52], relating to the Statewide Rabies Control Program, the owner of any dog kept or exhibited in Wisconsin (other than a dog kept for educational or scientific purposes) shall have the dog vaccinated against rabies by a veterinarian at no later than 5 months of age and revaccinated within one year after the initial vaccination. Any person (including out-of-state exhibitors) who imports a dog into Wisconsin (for exhibition or any other purpose) must have a valid interstate health certificate or certificate of veterinary inspection for that dog, regardless of the age of the dog. The certificate must be completed by a veterinarian; accompany the dog when it enters this state; and indicate the current vaccination status of the dog. Vaccinations shall be administered by a veterinarian and comply with age and time standards and label instructions approved by the federal bureau for the type of vaccine used.

#### AKC National Owner-Handled Series

The purpose of the AKC National Owner Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/handlers to compete against their peers. The determination of the awards in the AKC National Owner Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.

- There is no additional fee to enter this competition.
- Entries must be marked as eligible to compete in the AKC NOHS prior to the closing of entries for that show.
- The handler must be an owner of record according to the AKC's records as of the date of the show.
- · Professional handler, household members and current assistants to professional handlers in conformation are not eligible to exhibit in this competition. A current assistant is defined as anyone employed by a professional handler on a full time basis, or assisting a professional handler at the show or any show during the cluster/weekend.
- Professional handler is defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
- Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition. Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner Handled Series competition (Group and Best in Show). Any person may exhibit the dog in the regular Group and Best in Show competitions.
- Eligibility restrictions apply to all members of the same household.
- Dogs declared eligible must be identified by an asterisk or other representative mark in the judge's book. steward's book, and the show catalog. The Owner Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non regular classes. This excludes all dogs defeated during class and winners competition for the regular show.
- · If the Best of Breed/Variety winner of the regular show is eligible for the AKC National Owner Handled Series competition, it will also be awarded Owner Handled Best of Breed. In this case, the dog will be eligible to compete in group competition for the regular show and group competition for the AKC National Owner Handled Series.
- · If the regular show Best of Breed/Variety winner is not eligible for AKC National Owner Handled Series competition and the regular show Best of Opposite Sex to Best of Breed/Variety is eligible, the regular show Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner Handled Best of Breed.
- · If neither the Best of Breed/Variety nor the Best of Opposite Sex to Best of Breed/Variety from the regular show is eligible for the AKC National Owner Handled Series competition and both the Select Dog and Select Bitch are eligible, the judge is to choose Owner Handled Best of Breed from the Selects and any eligible Winners Dog or Winners Bitch.
- · If one of the Selects from the regular show is eligible for AKC National Owner Handled Series competition, excuse all eligible champions and non regular class winners of the same sex and then choose Owner Handled Best of Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed/Variety, Best of Opposite Sex to Best of Breed/Variety, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog that competed in Best of Breed including Winners Dog or Winners Bitch as the Owner Handled Best of Breed.
- · If no dog remaining in the ring is eligible for the AKC National Owner Handled Series competition, Owner Handled Best of Breed will not be awarded and the Breed/Variety will not be represented in group competition for the AKC National Owner Handled Series.

The Stud Dog may be entered separately in one of the Regular or Non-Regular Classes or if a Champion of Record, for Best of Breed Competition or may be entered for Stud Dog Class only at the regular entry fee. The Get MUST be entered in one of the Regular Classes. The Stud Dog unit shall be considered as one entry and requires only one entry fee.
