THE FOLLOWING RULES WILL BE STRICTLY ENFORCED

• **PARKING:** You must be parked by parking person. We will accept RV's. Anyone coming in after 10:00 P.M. will be temporarily parked on an inside road of the fairgrounds (NOT YOUR PERMANENT SITE). You will be taken to your permanent site. No Saved spaces unless you pay for them when you come in the fairgrounds. Reserved parking is for club members working and volunteers. You may save space if paid for when you come in fairgrounds.

YOU WILL BE CHARGED \$35.00 FOR EACH RV PLUG IN THAT YOU USE, NO EXCEPTIONS.

- **Reserved space for grooming will be for club members who are working and volunteers. A reserved grooming area will be cordoned off for the Affenpinschers Club of America's National Specialty. Grooming Area will be available to exhibitors on Wednesday at 2:00 P.M. First come first serve. Crates must be stacked. Area will be monitored. No area rugs on floor. Please keep your area clean. No grooming space may be saved.**

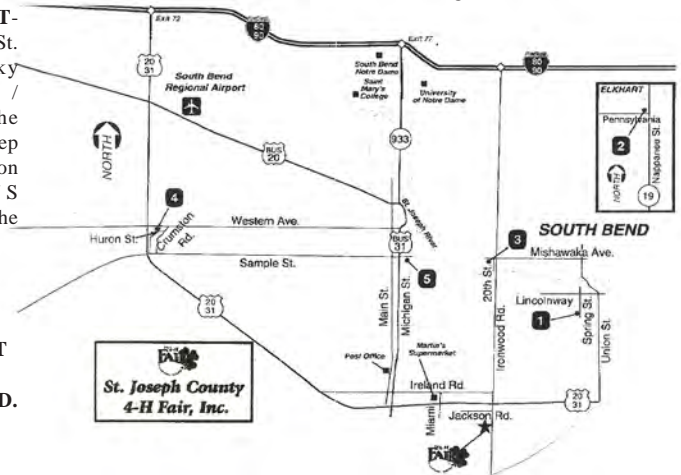

To be eligible to compete in non-regular Veteran Classes, dogs and bitches must not be spayed or neutered and must meet all requirements, according to Chapter 11, Section 8, Rules Applying to Dog Shows.

BEST OF BREED (VARIETY) COMPETITION

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

for Affenpinschers (Saturday Only)

As the judge's decision in the Non-Regular Classes Involving Multiple Dog Entries will be based on the merits of more than one dog or bitch, none of the dogs or bitches making up the entry judged first in these classes will be eligible for Best of Breed by virtue of having won these classes.

Stud Dog Class-For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the Regular or Non-Regular Classes or if a Champion of Record, for Best of Breed/Variety Competition or may be entered for Stud Dog Class only at the regular entry fee. The Get MUST be entered in one of the Regular Classes. The Stud Dog unit shall be considered as one entry and requires only one entry fee. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with his Get. Get only to be judged on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for the Breed.

Brood Bitch Class-Same as Stud Dog Class except substitute Brood Bitch for Stud Dog and Produce for Get.

Brace Class-Effective January 1, 2005. A brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The dogs comprising a Brace MUST be named at the time of entry. If a dog which is to be part of a Brace is not entered in another class it must be entered for "Brace Class Only". In making entries for "Brace Class Only" full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes "Brace Class". If more than one Brace is entered by the same owner, the dogs comprising EACH Brace unit must be so designated "Brace No. 1.", "Brace No. 2", etc. PLEASE SUBMIT BRACE ENTRIES TOGETHER.

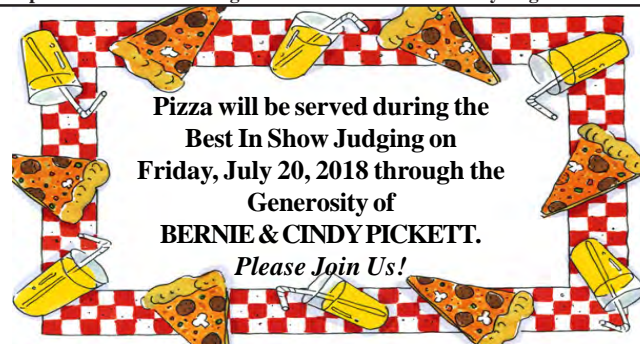

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

Lagotti Romagnoli, American Water Spaniels, Boykin Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Sussex Spaniels*, Welsh Springer Spaniels, Basset Hounds*, Cirnechi dell'Etna, Whippets, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Bulldogs*, Chinese Shar-Pei*, Chow Chows*, Finish Spitz, Keeshonden, Norwegian Buhunds, Entlebucher Mountain Dog, Finnish Lapphunds, Polish Lowland Sheepdogs, Spanish Water Dogs & Norrbottenspets (misc).

*By Board approved policy Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei & Chow Chows must be judged on the ramp in all conformation competition associated with AKC conformation dog shows or at which AKC conformation titles may be earned.

A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Event Secretary prior to judging. AKC approval is not required. This policy extends to Junior Showmanship, the 4-6 Month

Beginner Puppy Competition, the AKC National Owner Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. The list of Table and Ramp breeds can be found on the AKC Website under Conformation Judges – Announcements. Emergencies in emergency situations, with the approval of the Show Chair, breeds customarily examined on the ground may be examined on a ramp, not on a table. An emergency is defined as a temporary condition that arose immediately prior to or at a dog show. Convalescence from a medical procedure, illness and recuperation from injuries are examples of conditions that are not emergencies.

The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund).

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
