Dogs are not required to be at the show until scheduled time of judging. All dogs not needed for further judging will be excused.

SHOW LOCATION will be available to exhibitors at 3:00 P.M., FRIDAY, MAY 12, 2017.

Expo Center grounds are open 24 hours a day but the buildings will be locked between 10:00pm & 6:00am each day.

ENTRY FEES-EACH DAY & LIMITS

NOTE: ENTRY FEES MUST BE RECEIVED FOR EACH ENTRY FOR EACH EVENT! IF FEES ARE RECEIVED FOR ONLY ONE EVENT, ONLY THE FIRST EVENT WILL BE PROCESSED.

ENTRY FEE is \$27.00 for the first entry of each dog for each event, except in Puppy & Bred-by-Exhibitor class which is \$20.00 for each event. Each Additional Entry of the same dog is \$22.00 for each event. JUNIOR SHOWMANSHIP is \$10.00 for each event if entered for 'Junior Showmanship Only' or if an Additional Entry. Rally is \$27.00 for the first entry for each event; each additional entry of the same dog in Rally is \$22.00 for each event. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, or the \$3.50 AKC Recording Fee on each entry of a dog in Rally and a \$3.00 for each additional entry of the same dog. (There is no recording fee or event service fee for junior showmanship, sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.) When a dog is entered in more than one class, the highest priced class is considered the first entry.

NOTICE: Please put breed & name of show on check.

ENTRIES CLOSE at the Superintendent's Office, WEDNESDAY NOON (EDT), APRIL 26, 2017, after which time entries will not be accepted, altered or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules or Chapter 1, Section 16 of the Obedience Regulations or Chapter 1, Section 13 of the Rally Regulations. **OBEDIENCE & RALLY ENTRIES CLOSE** at the Superintendent's Office, WEDNESDAY NOON (EDT), APRIL 26, 2017, unless limits have been reached prior to this date.

EXHIBITORS PLEASE NOTE

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

"Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a nose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment."

No dogs that are disqualified for aggression will be allowed to enter these Shows, nor be allowed to be on the grounds. In addition, no aggression reinstatement procedures will be performed at these Shows.

DIRECTIONS TO OAKWOOD HILLS ANIMAL HOSPITAL: 4616 Commerce Valley Road, Eau Claire, WI 54701 • 715-835-0112. From the show site, turn right out the gate onto Lorch Avenue to Hwy. 93. Go North on 93 across I-94 to Commerce Valley Road. Take a right on Commerce Valley Road 1/2 block to the hospital. The hospital is less than 1 mile from show site.

• NOTE •

In order to comply with the provisions of Wisconsin Statutes [s. 95.21 (2)] and Administrative Codes [s. ATCP 11.52], relating to the Statewide Rabies Control Program, the owner of any dog kept or exhibited in Wisconsin (other than a dog kept for educational or scientific purposes) shall have the dog vaccinated against rabies by a veterinarian at no later than 5 months of age and revaccinated within one year after the initial vaccination.

Any person (including out-of-state exhibitors) who imports a dog into Wisconsin (for exhibition or any other purpose) must have a valid interstate health certificate or certificate of veterinary inspection for that dog, regardless of the age of the dog. The certificate must be completed by a veterinarian; accompany the dog when it enters this state; and indicate the current vaccination status of the dog.

Vaccinations shall be administered by a veterinarian and comply with age and time standards and label instructions approved by the federal bureau for the type of vaccine used. Additional information regarding these regulations may be obtained from the Wisconsin State Veterinarian at 608-224-4888.

ATTENTIONEXHIBITORS

Indianhead Kennel Club's Show Committee **will exercise its right to suspend any person from all privileges of AKC for conduct prejudicial to the best interests of pure bred dogs, which includes abuse of a Motel/Hotel Property. (Chapter 13, Section 1 of the Rules Applying to Registration and Discipline)**

Rules that MUST be followed:

1. Notify you have dogs when making your reservations.
2. No unattended dogs allowed in rooms.
3. No uncrated dogs allowed in rooms.
4. No bathing or grooming of dogs in rooms.
5. Exercise dogs in designated areas only.
6. Clean up after your dog.

It is recommended that you check your room over when you check in as you will be financially responsible for any damage.

Hotel policies may change toward dogs, please verify current policies when making reservations.

SHOW SITE RULES

- * Smoking is not allowed in any building or within 20ft and any building entrance.
- * The show site will be available to exhibitors at 3:00 PM on Friday, May 12, 2017. Dogs must be removed from the show grounds immediately after Best In Show judging on Sunday, May 14, 2017.
- * There will be a Parking Fee of \$5.00 per day.
- * All areas of the Show site are Handicapped Accessible.
- * Restrooms are available Inside & Outside.
- * Admission is Free for Spectators.
- * Grooming will be in designated areas only. To assure enough covered grooming for all exhibitors, chairs for seating will not be allowed in the open grooming buildings.
- * Grooming will be on a first come, first served basis.
- * Electricity will be available only to those inside the grooming buildings.
- * No grooming space can be roped off or held with empty crates or by any other means.
- * The show committee reserves the right to condense exhibitor's grooming area.
- * Each exhibitor is responsible for cleaning up after their dogs in the show buildings and on the show grounds, and for keeping their grooming areas clean as demanded by show property management.
- * Public exercise pens will be provided and must be attended by owner or agent while in use.
- * Private exercise pens are allowed in **Reserved** grooming areas and in designated areas outside the grooming buildings. The owner or agents using these pens are responsible for **all** clean up. All exercise pens in the Reserved grooming areas must have a plastic liner on the floor and wrapped no less than two feet up all sides.
- * Dogs are allowed in the rings during judging only.
- * **The Agility ring is off limits to all dogs and people.**
- * Puppies under the age of 6 months are not allowed on the show grounds unless attending the CERF clinic.
- * Turn off cell phones before entering the ring.
- * Dogs that are not entered are not allowed on show grounds.
- * Electrical outlets must be shared.
- * Indianhead Kennel Club reserves the right to substitute a prize for equal or greater value.
- * All trophies must be claimed the day of the show. Trophies will not be mailed or shipped.
- * Parking is allowed in designated areas only. Parking spaces can not be saved from day to day.
- No spaces may be reserved or saved by placing cones in open areas or by any other means.
- Cones or anything else used in this manner will be removed by the Parking Committee.
- * No private tents/canopies/pop-up's will be allowed within 20 ft. of any ring.
- * Exhibitors may leave dogs and equipment in the buildings at your own risk.
- * The buildings will be locked at 10:00 PM each night and will open at 6:00 AM each morning.
- * No grooming tables, crates or strollers allowed in the pavilion near the outdoor ring entrances.
- * Dogs are not allowed in the bathroom or shower areas.
- * Spectator chairs will be allowed ringside in the indoor ring buildings as long as they don't impede or interfere with foot traffic.
- * Crates and small grooming tables will be allowed ringside 5 minutes before judging but must be removed immediately after Best of Breed judging. Ring Stewards and the Chief Ring Steward will be monitoring. Indianhead Kennel Club may change this direction if abused or impedes traffic flow. This will be strictly enforced. Indianhead Kennel Club show committee members will remove tables/crates if these guidelines are not met.
- * The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is expressly understood that exhibitors will exercise control & restraint over their children at all times.

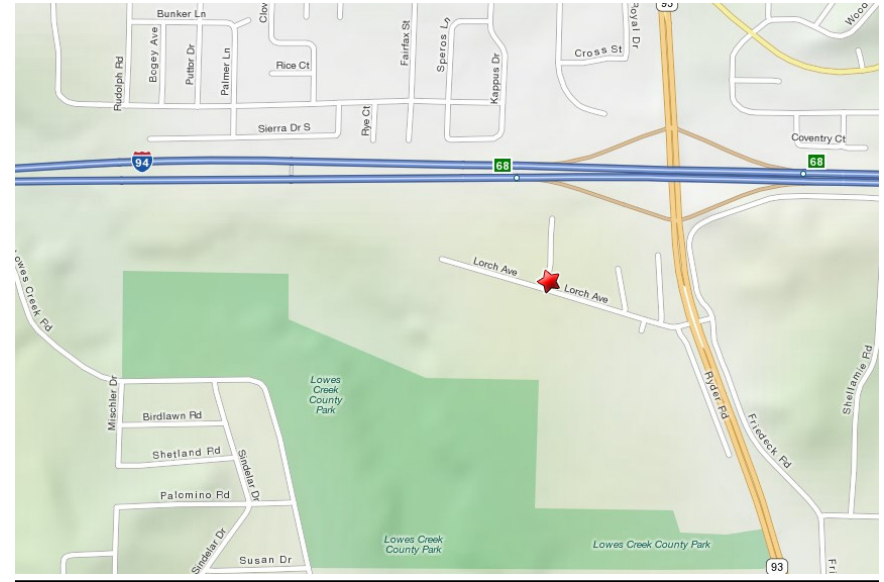

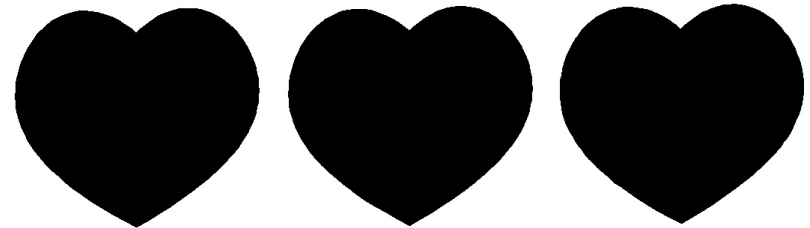

The Indianhead Kennel Club as part of its All-Breed Show, will hold a Best Bred-By-Exhibitor Competition. Competition will be for Best Bred-By-Exhibitor in Breed/Variety, Bred-By-Exhibitor in Group (with placements one through four) and Best Bred-By-Exhibitor in Show.

RULES: During the course of regular judging, the assigned judge will select a Best Bred-by-Exhibitor from the Bred-by-Exhibitor class winners. *By Board approved policy Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei & Chow Chows must be judged on the ramp in all conformation competition associated with AKC conformation dog shows or at which AKC conformation titles may be earned.

A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent prior to judging. AKC approval is not required. This policy extends to Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

The list of Table and Ramp breeds can be found on the AKC Website under Conformation Judges - Announcements. Emergencies In emergency situations, with the approval of the Show Chair, breeds customarily examined on the ground may be examined on a ramp, not on a table. An emergency is defined as a temporary condition that arose immediately prior to or at a dog show. Convalescence from a medical procedure, illness and recuperation from injuries are examples of conditions that are not emergencies. The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund).
