When a dog is entered in more than one class, the highest priced class is considered the first entry.

ENTRY FEE is \$28.00 for the first entry of each dog for each event except for Puppy & Bred-By-Exhibitor Classes which are \$24.00 for each event. Each Additional Entry of the same dog is \$24.00 for each event. **JUNIOR SHOWMANSHIP** is \$20.00 for each event if entered for 'Junior Showmanship Only' or if an Additional Entry; \$10.00 for each event. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes. (There is no recording fee or event service fee for junior showmanship, sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.) **ENTRIES CLOSE at Superintendent's Office, WEDNESDAY NOON (EDT), SEPTEMBER 26, 2018,** after which time entries will not be accepted, cancelled, altered or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

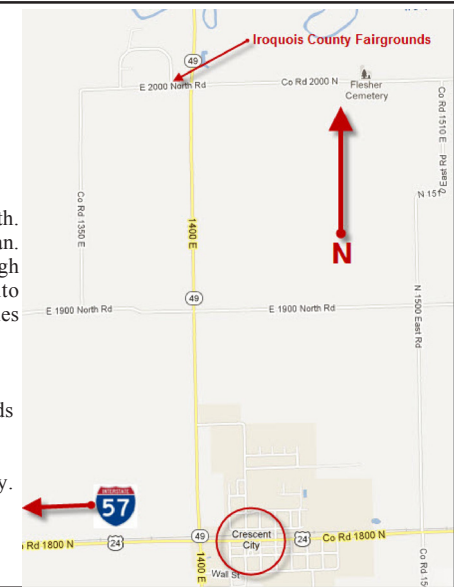
ROUTE TO THE SHOW

FROM THE NORTH – Take Route 49 South. If you are coming from I 57, exit at Ashkum, turn Left (East) and this will take you onto Route 45. Drive about 5 miles. Then turn Right onto Route 49. The Fairgrounds are about 5 miles South of this intersection.

FROM THE SOUTH – Take Route 49 North. If you are coming from I 57, exit at Gilman. Take a Right onto Route 24. Continue through Gilman to Crescent City. Take a Left onto Route 49. The Fairgrounds are about 2 miles North of Crescent City.

FROM THE WEST – Take Route 24 East. Continue through Gilman to Crescent City. Take a Left onto Route 49. The Fairgrounds are about 2 miles North of Crescent City.

FROM THE EAST – Take Route 24 West. Continue through Watseka to Crescent City. Take a Right onto Route 49. The Fairgrounds are about 2 miles North of Crescent City.

A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Event Secretary prior to judging. AKC approval is not required. This policy extends to Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. The list of Table and Ramp breeds can be found on the AKC Website under Conformation Judges - Announcements.

Emergencies In emergency situations, with the approval of the Show Chair, breeds customarily examined on the ground may be examined on a ramp, not on a table. An emergency is defined as a temporary condition that arose immediately prior to or at a dog show. Convalescence from a medical procedure, illness and recuperation from injuries are examples of conditions that are not emergencies.

The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund).
