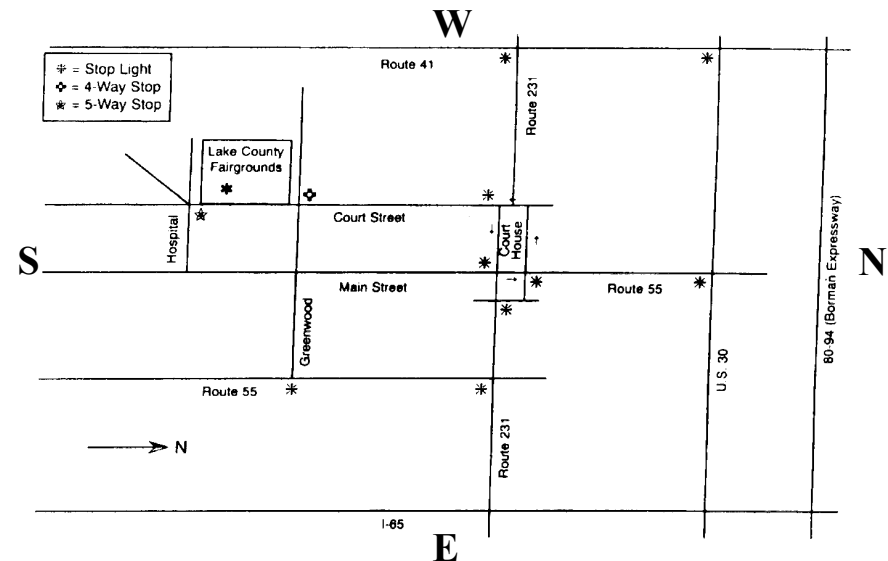

The Club, their members, directors, officers, agents, show superintendent, and the said employees of the said kennel club and/or its superintendents will not be liable for any loss or injury which may be sustained through the loss, theft, injury and/or death of dogs entered in this event whether said loss, theft, injury and/or death is or are caused by the negligence or carelessness of the said Kennel Clubs, their members, directors, officers, agents, superintendents, and/or employees of the said Kennel Clubs and/or employees of their superintendents or by negligence of any person or any other cause.

- **NO DOGS ARE ALLOWED IN THE RESTROOMS OR OTHER DESIGNATED AREAS.**
- **DOGS MUST BE ON A LEASH** or confined to their crates except when being judged or in the exercise pens provided.
- **THE LAKE COUNTY FAIRGROUNDS** will be available on Friday and Saturday nights for exhibitors who wish to leave their dogs in the building overnight. The building will be locked promptly at 9:00 p.m. each night and will not reopen until 6:30 a.m. the following morning.
- **PARKING IS FREE.**
- **ADMISSION FEE FOR SPECTATORS:** \$2.00 - Adults, \$1.00 - Seniors & Children 12 yrs. & under.
- **GROOMING AND CRATING WILL BE IN DESIGNATED AREAS ONLY. TO ASSURE ENOUGH ROOM FOR ALL EXHIBITORS WISHING TO GROOM, ALL CRATES MUST BE STACKED, NO SPACE CAN BE ROPED OFF OR HELD WITH EMPTY CRATES. THE SHOW COMMITTEE HAS THE RIGHT TO LIMIT THE NUMBER OF GROOMING TABLES PER EXHIBITOR.**
- **NO MESH CRATES ALLOWED IN THE BUILDING.**
- **BUILDING & RESTROOMS ARE HANDICAPPED ACCESSIBLE.**
- **HANDICAP PARKING** – Limited handicap parking is available.
- **NO PARKING OR BLOCKING OF ANY ENTRANCE OR EXIT OF ANY BUILDING EXCEPT FOR LOADING OR UNLOADING. - **CLEAN UP NOTICE:** Exhibitors/Handlers will be held responsible for keeping their grooming & crating areas clean. Failure to do so may result in disciplinary action. All litter must be placed in containers that are provided on the grounds and in the buildings.
- **EXHIBITORS MUST CLEAN UP AFTER THEIR OWN DOGS IN ALL GRASS AND PAVED AREAS OF THE FAIRGROUNDS.** For the convenience of the exhibitors and their dogs, exercise pens will be available for the animal's toiletry needs. **PLEASE EXERCISE DOGS BEFORE ENTERING THE SHOW RING.**
- **Electricity is provided on a limited basis AND IT IS EXPECTED THAT IT WILL BE SHARED.**
- **NO STROLLERS WILL BE ALLOWED IN THE EXPOSITION BUILDINGS.** The welfare of a child is assumed to be the responsibility of the adult bringing the child to the show. It is distinctly understood that adults will exercise control and restraint over their children at all times.
- **NO SMOKING IN BUILDING AT ANY TIME.**
- **NO ALCOHOLIC BEVERAGES.** The Lake County Fairgrounds prohibits any alcoholic beverages to be carried in.
- **No cutting of rope or tape or removal of any barricade.**
- **No grooming or crates allowed at ringside.** Show & Go crates will be allowed at ringside in designated areas during that breeds' judging at the discretion of the Show committee.
- **NO CRATING OR GROOMING IN MAIN AISLES.**
- **Chairs in the grooming area may be limited at the discretion of the Show Committee.**
- **We recommend that all dogs present at the show be fully immunized.**
- **Private exercise pens must be set-up on plastic floor sheeting and must be down each morning by 7:00 a.m.** No private ex-pens during show hours. You may use private ex-pens in grooming area (as space allows) 30 minutes after Best in Show.
- **At no time in the show building will matting, carpeting, or other material larger than 4' x 4' be allowed.**
- **Grooming area is on a first come-first served basis.** Empty space cannot be saved-don't ask.

- **ALL RV and overnight parking is by reservation only and in designated areas. Space is limited. Spaces Assigned by Club.**
- **By local ordinance, the fairgrounds gates are closed at 9:00 each evening and reopen at approx. 6:30 am. No RVs will be admitted on Friday or Saturday evening after the fairgrounds is closed. No exceptions are made under Fairgrounds rules.** Emergency exit instructions will be provided to those in place by 9:00 pm each evening.
- Reservations are on a first come, first served basis within the grounds; no specific space is reserved for any party.
- Reservations must indicate and pay for electrical to have access to electrical hookups! **If you pay for a space without electrical, you will not be permitted to plug into the Fairground electrical hookups.** Electrical hookups are only permitted in designated spaces. **Limit two plug-ins per space** where electrical has been paid for. **FOUR-TO-SIX MONTH BEGINNER PUPPY COMPETITION**

**SATURDAY, JUNE 22, 2019**

The Four-to-Six Month Beginner Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will not be divided by sex in this competition. Classes will be offered for Breeds & Varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class Breeds as listed in Chapter 3, Section 23. The Miscellaneous Class competition will be equivalent of Group Competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS Competition will be the equivalent of Group Competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A Foreign born dog may enter this class if they are registered in the country of origin.
- FSS Number of FSS Registered litter number will be required for Miscellaneous and FSS Breed Entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers are not permitted to exhibit in this class. Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*
- Exhibitors should open their dog's mouth for examination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs.
- Male puppies without 2 fully descended testicles need not be disqualified or excused but the judge's book must describe the condition and Certificate of Merit points must be withheld.
- Dogs with breed standard disqualifications should not be excused but may not receive placements. However, dogs with age related disqualifications such as color (as related to age), height, teeth etc. are permitted to receive awards in the 4-6 Month Beginner Puppy classes.
- Dogs must be excused for attacking a person or other dogs.
- No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed.

*Dealing with Misconduct* will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise.

An FSS Open Show is an informal American Kennel Club sanctioned conformation event at which Championship points are not earned but rather Certificate of Merit (CM) points are awarded to this introductory AKC conformation suffix title. The FSS Open Shows are events at which dog clubs, judges, stewards, and exhibitors and their dogs gain experience needed for licensed events.

All of the *Rules Applying to Dog Shows* will apply to sanctioned FSS Open Shows, except where otherwise stated in these Regulations which are subject to amendment by the AKC Board of Directors.

- Dogs must be at least 4 months of age on the date of the event.  
 The following breed classes will be offered at all FSS Open Shows: (All Classes Divide by sex)

- 4-6 Month Puppy Class
- 6-9 Month Puppy Class
- 9-12 Month Puppy Class
- Bred-By-Exhibitor Class
- Open Class

**BEST OF BREED COMPETITION**

- Miscellaneous breeds will be considered equivalent to a Group.
- The Miscellaneous Class winner will compete with the Group winners for Best in Show.
- FSS breeds will be considered equivalent to a Group.
- The Best FSS winner will compete with the Group winners for Best in Show.
- Dogs less than 4 months of age are ineligible to be on the grounds of licensed or member shows during AKC events.
- Dogs are required to be vaccinated in accordance with their veterinarian's protocol (including rabies vaccination) in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.
- Professional handlers or agents are only permitted to exhibit in FSS Open Shows if they are listed as an owner of record of the dog being exhibited. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.*
- No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed.
- *Dealing with Misconduct* will be applicable to any person and dog entered in this competition.
- Judges are expected to comply with *Rules Applying to Dog Shows* and *Rules, Policies, and Guidelines for Conformation Dog Show Judges* except as follows:
  - Breed standard disqualifications (i.e. color, height, full dentition, etc.) need not be considered in the 4-to-6 Month Puppy classes and male puppies without 2 fully descended testicles need not be disqualified or excused in the 4-to-6 Month Puppy class but the judge's book must describe the condition.
  - In all other classes, male puppies without 2 fully descended testicles need not be disqualified but should be excused and the judge's book must describe the condition and Certificate of Merit points withheld.
  - Judges may ask exhibitors if they prefer to open their dog's mouth for examination. However, judges have the authority to personally open the dog's mouth.
  - No protests against dogs for height, weight or any other breed specific disqualification may be entertained at FSS Open Shows.
  - A dog with a disqualifying condition or behavior shall not be disqualified but shall simply be excused for the day. The judge may only disqualify dogs for attacking in the ring.

The Certificate of Merit (CM) title is an introductory title to AKC conformation events. Entrants in each breed shall compete for Best of Breed and Best of Opposite Sex to Best of Breed. Winners of the Best of Breed in each of the individual breeds will be awarded points toward the CM title based on the number of dogs competing in their breed. Best of Opposite Sex to Best of Breed in each of the individual breeds will be awarded points towards the Certificate of Merit (CM) title based on the total number of dogs competing in their sex. Group winners will be eligible for the points based on the total number of dogs that competed in the Group. Best in Show will be eligible for the points based on the total number of dogs that competed in the show.
