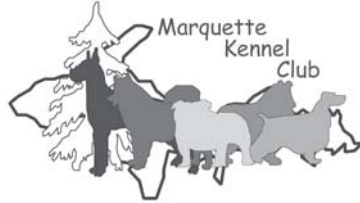

Dogs are not required to be at the show until scheduled time of judging. All dogs not needed for further judging will be excused.
SHOW LOCATION WILL BE AVAILABLE TO EXHIBITORS AT 4:00 P.M., THURSDAY, AUGUST 31, 2017. There will be no overnight camping allowed on the grounds Sunday Night, unless authorized by the club. GROUNDS MUST BE VACATED BY 7:00 P.M., Sunday, September 3, 2017.

ENTRY FEES - FOR EACH DAY & LIMITS

NOTE: ENTRY FEES MUST BE RECEIVED FOR EACH ENTRY FOR EACH EVENT EACH DAY! IF FEES ARE RECEIVED FOR ONLY ONE EVENT, ONLY THE FIRST EVENT WILL BE PROCESSED! ENTRY FEE is \$28.00 for the first entry of each dog for each event, except for Puppy Classes which are \$24.00 for each event. Each additional entry of the same dog will be \$24.00 for each event. Best Veteran Special Attraction fee is \$24.00 (where offered). JUNIOR SHOWMANSHIP is \$20.00 for each event if entered for Junior Showmanship Only' or if an Additional Entry; \$16.00 for each event. First Rally Entry is \$28.00 for each event. Each additional Rally Entry of the same dog in Rally will be \$24.00 for each event. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, or the \$3.50 AKC Recording Fee on each entry of a dog in Rally and a \$3.00 for each additional entry of the same dog. EXHIBITORS PLEASE NOTE

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

6. If you would like an acceptance confirmation request that we email you or send a self-addressed stamped envelope.
7. All crates need to be stacked

NOVICE JUNIOR CLASS-For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

NOVICE INTERMEDIATE CLASS-For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

NOVICE SENIOR CLASS-For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

OPEN JUNIOR CLASS-For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

OPEN INTERMEDIATE CLASS-For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

OPEN SENIOR CLASS-For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS-This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition from the Open Class. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors Meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

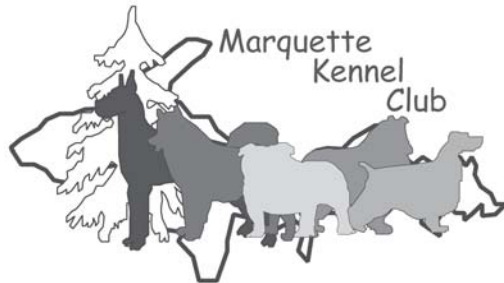

Emergencies in emergency situations, with the approval of the Show Chair, breeds customarily examined on the ground may be examined on a ramp, not on a table. An emergency is defined as a temporary condition that arose immediately prior to or at a dog show. Convalescence from a medical procedure, illness and recuperation from injuries are examples of conditions that are not emergencies. The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund).

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
