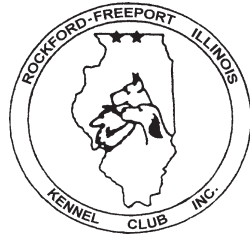

ENTRY FEE is \$29.00 for the first entry of each dog for each event, except for Puppy & Bred-By-Exhibitor Classes which are \$25.00 for each event. Each Additional Entry of the same dog is \$24.00 for each event. JUNIOR SHOWMANSHIP is \$23.00 if entered for 'Junior Showmanship Only' for each event or FREE if entered as an Additional Entry. Sweepstakes & Veteran Sweepstakes Entry Fee is \$15.00 for each event (*where offered*). 4-6 Month Beginner Puppy fee is \$10.00 for the first entry of each dog. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, or the \$2.00 AKC Event Service Fee on each entry in 4-6 Month Beginner Puppy. (There are no recording fees or event service fees for sweepstakes, Junior showmanship, futurities, brace/team, multi-dog classes, or special attractions.)

Rockford-Freeport Illinois Kennel Club, Inc., as part of its All-Breed show, will hold a Best Puppy Competition. Competition will be for Best Puppy in Breed/Variety, Best Puppy in Group (with placements one through four) and Best Puppy in Show.

Rules: During the course of regular judging, the assigned judge will select a Best Puppy from the class winner of the 6 months & under 9 months, and from the 9 months & under 12 months classes. This will be done after the Best of Breed judging unless the Best Puppy award is automatic. Example: An entry from the puppy classes is awarded Best of Winner or Best of Breed/Variety. Only dogs and bitches undefeated in Puppy Class are eligible for Best Puppy Competition. If the first place winner is not present, the second place winner **MAY NOT** compete. The Rockford-Freeport Illinois Kennel Club as part of its All-Breed Show, will hold a Best Bred By Exhibitor Competition. The Competition will be for Best Bred By Exhibitor in Breed/Variety, Best Bred By Exhibitor in Group (with placements one through four) and Best Bred By Exhibitor in Show.

RULES: During the course of regular judging, the assigned judge will select a Best Bred-By-Exhibitor in each Breed/Variety from the Bred-By-Exhibitor class winners. This will be done after the Best of Breed/Variety Competition unless the Best Bred-By-Exhibitor award is automatic. Example: An entry from the Bred By Exhibitor class is awarded Best of Winners or Best of Breed/Variety. Only dogs and bitches undefeated in a Bred-By-Exhibitor class are eligible for the Best Bred-By-Exhibitor Competition. If the first place winner is not present, the second place winner **may not compete**.

All Best Bred-By-Exhibitor in Breed/Variety will compete in their respective Best Bred By Exhibitor Group. All Best Bred-By-Exhibitors in Group will compete for Best Bred-By-Exhibitor in Show.

THERE WILL BE NO ADDITIONAL ENTRY FEE FOR THIS COMPETITION. DOGS MUST BE ENTERED IN THE REGULAR BRED BY EXHIBITOR CLASS TO BE ELIGIBLE FOR THE BEST BRED-BY-EXHIBITOR COMPETITION.

GROUP AND BEST IN SHOW JUDGING:

Bred-By-Exhibitor Group judging will begin following regular Group judging. Regular Group judging will be conducted while Bred-By-Exhibitor Group judging occurs in another ring. Example: Regular Sporting. Group judging is completed in Ring 1; Bred-By-Exhibitor Sporting Group will then begin in Ring 3. Best Bred-By-Exhibitor in Show will precede regular Best In Show judging.

FOUR-TO-SIX MONTH BEGINNER PUPPY COMPETITION

EVENT #2018041402

SATURDAY, SEPTEMBER 29, 2018

The Four-to-Six Month Beginner Puppy competition shall be for dogs that are four months of age and under six months on the day of the event. Classes will not be divided by sex in this competition. Classes will be offered for Breeds & Varieties and divided into Groups as described in Chapter 3, Section 1 of *Rules Applying to Dog Shows* and the Miscellaneous Class Breeds as listed in Chapter 3, Section 23. The Miscellaneous Class competition will be equivalent of Group Competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS Competition will be the equivalent of Group Competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A Foreign born dog may enter this class if they are registered in the country of origin.
- FSS Number of FSS Registered litter number will be required for Miscellaneous and FSS Breed Entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*
- Exhibitors should open their dog's mouth for examination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs.
- Male puppies without 2 fully descended testicles need not be disqualified or excused but the judge's book must describe the condition and Certificate of Merit points must be withheld.
- Dogs with breed standard disqualifications should not be excused but may not receive placements. However, dogs with age related disqualifications such as color (as related to age), height, teeth etc. are permitted to receive awards in the 4-6 Month Beginner Puppy classes.
- Dogs must be excused for attacking a person or other dogs.
- No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed. Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise.

******* AKC National Owner-Handled Series *******

SUNDAY, SEPTEMBER 30, 2018

The purpose of the AKC National Owner Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/handlers to compete against their peers. The determination of the awards in the AKC National Owner Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.

- There is no additional fee to enter this competition.
- Entries must be marked as eligible to compete in the AKC NOHS prior to the closing of entries for that show.
- Dogs declared eligible must be identified by an asterisk or other representative mark in the judge's book, steward's book, and the show catalog. An emergency is defined as a temporary condition that arose immediately prior to or at a dog show. Convalescence from a medical procedure, illness and recuperation from injuries are examples of conditions that are not emergencies.

The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund).

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
