ENTRIES CLOSE at Superintendent's Office, Wednesday Noon (EDT), SEPTEMBER 5, 2018, after which time entries cannot be accepted, cancelled, altered or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

SHOW HOURS EACH DAY 6:00 A.M. to 5:00 P.M. - CDT

Dogs are not required to be at the show until scheduled time of judging. All dogs not needed for further judging will be excused.
SHOW LOCATION AVAILABLE TO EXHIBITORS Fri., Sept. 21, 2018 Noon - 9:00 P.M.

ENTRY FEES EACH DAY & LIMITS

NOTE: ENTRY FEES MUST BE RECEIVED FOR EACH ENTRY FOR EACH EVENT EACH DAY! IF FEES ARE RECEIVED FOR ONLY ONE EVENT, ONLY THE FIRST EVENT WILL BE PROCESSED.
ENTRY FEE is \$28.00 for the first entry of each dog for each event, except for Puppy Classes which are \$22.00 for each event. Each Additional Entry of the same dog is \$16.00 for each event. JUNIOR SHOWMANSHIP is \$16.00 for each event if entered for 'Junior Showmanship Only' or if an Additional Entry; \$10.00 for each event. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, or the \$3.50 AKC Recording Fee on each entry of a dog in Rally and a \$3.00 Fee for each additional entry of the same dog. (There is no recording fee or event service fee for junior showmanship, sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.)

ENTRIES CLOSE at Superintendent's Office, **WEDNESDAY NOON (EDT), SEPTEMBER 5, 2018**, after which time entries will not be accepted, cancelled, altered or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

MAKE CHECKS and Money Orders payable to Roy Jones Dog Shows, Inc. (Returned Check Charge \$40.00). All Checks Must Have Show(s) & Breed(s) entered written on the face. **THIRD PARTY CHECKS WILL NOT BE ACCEPTED!**

ALL ENTRIES MUST BE SUBMITTED ON OFFICIAL AKC ENTRY FORMS, one dog per entry form. Photocopies of front & back will be accepted only if legible and official AKC size.

ENTRIES WILL NOT BE ACCEPTED WITHOUT SIGNATURE, FEES AND BACK ON ENTRY FORM WITH AGREEMENT, NOR WILL CREDIT CARDS BE ACCEPTED FOR MAIL-IN ENTRIES. ALL ENTRIES MUST BE SUBMITTED with checks drawn on U. S. Institutions or with International Money Orders in U. S. Funds.

EXHIBITORS PLEASE NOTE

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

"Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment."

No dogs that are disqualified for aggression will be allowed to enter these Shows, nor be allowed to be on the grounds. In addition, no aggression reinstatement procedures will be performed at these Shows.

ATTENTION OWNERS/EXHIBITORS OF FOREIGN REGISTERED DOGS

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1. 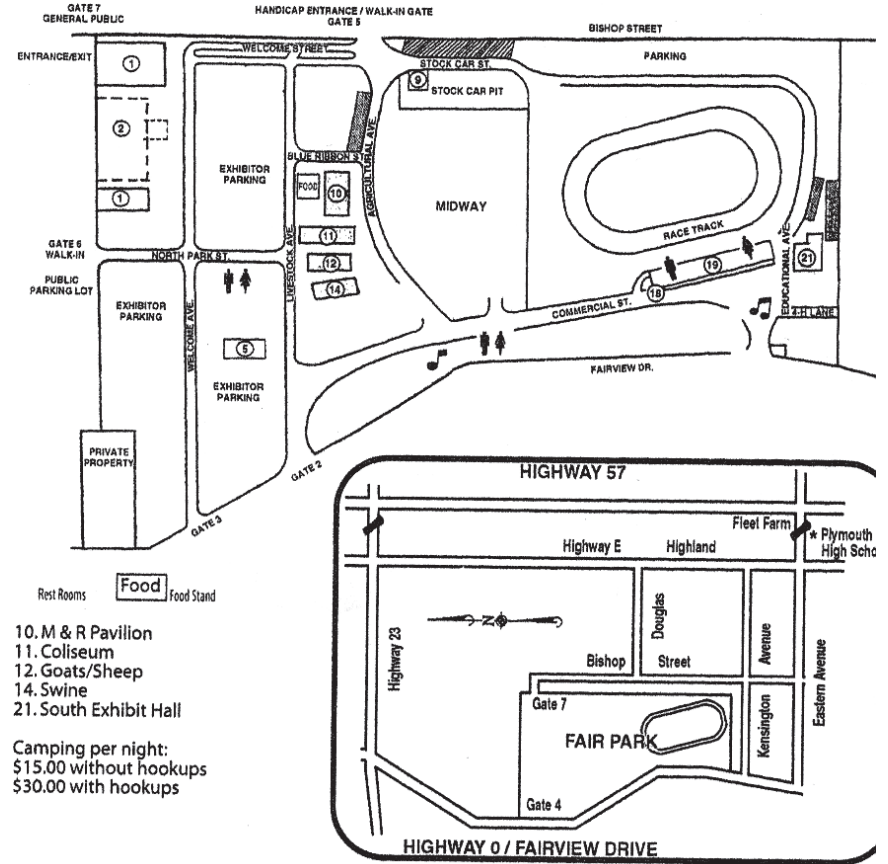

• NOTE •

In order to comply with the provisions of Wisconsin Statutes [s. 95.21 (2)] and Administrative Codes [s. ATCP 11.52], relating to the Statewide Rabies Control Program, the owner of any dog kept or exhibited in Wisconsin (other than a dog kept for educational or scientific purposes) shall have the dog vaccinated against rabies by a veterinarian at no later than 5 months of age and revaccinated within one year after the initial vaccination.

Any person (including out-of-state exhibitors) who imports a dog into Wisconsin (for exhibition or any other purpose) must have a valid interstate health certificate or certificate of veterinary inspection for that dog, regardless of the age of the dog. The certificate must be completed by a veterinarian; accompany the dog when it enters this state; and indicate the current vaccination status of the dog. Vaccinations shall be administered by a veterinarian and comply with age and time standards and label instructions approved by the federal bureau for the type of vaccine used.

A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Event Secretary prior to judging. AKC approval is not required. This policy extends to Junior Showmanship, the 4-6 Month

Emergencies In emergency situations, with the approval of the Show Chair, breeds customarily examined on the ground may be examined on a ramp, not on a table.

An emergency is defined as a temporary condition that arose immediately prior to or at a dog show. Convalescence from a medical procedure, illness and recuperation from injuries are examples of conditions that are not emergencies.

The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund).
