ENTRY FEES FOR EACH DAY & FOR EACH EVENT

NOTE: ENTRY FEES MUST BE RECEIVED FOR EACH ENTRY FOR EACH EVENT EACH DAY! IF FEES ARE RECEIVED FOR ONLY ONE EVENT, ONLY THE FIRST EVENT WILL BE PROCESSED.

ENTRY FEE is \$28.00 for the first entry of each dog for each event, except for Puppy Classes & Bred-by-Exhibitor which are \$24.00 for each event. Each Additional Entry of the same dog is \$10.00 for each event. JUNIOR SHOWMANSHIP is \$24.00 for each event if entered for 'Junior Showmanship Only' or if an Additional Entry; \$10.00 for each event. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes. (There is no recording fee or event service fee for junior showmanship, sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.)

ENTRIES CLOSE at Superintendent's Office, **WEDNESDAY NOON (EDT), SEPTEMBER 18, 2019**, after which time entries will not be accepted, cancelled, altered or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

When a dog is entered in more than one class, the highest priced class is considered the first entry. MAKE CHECKS and Money Orders payable to Roy Jones Dog Shows, Inc. (Returned Check Charge \$40.00). All Checks Must Have Show(s) & Breed(s) entered written on the face. **THIRD PARTY CHECKS WILL NOT BE ACCEPTED!**

ALL ENTRIES MUST BE SUBMITTED ON OFFICIAL AKC ENTRY FORMS, one dog per entry form. Photocopies of front & back will be accepted only if legible, and official AKC size.

EXHIBITORS PLEASE NOTE

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

No dogs that are disqualified for aggression will be allowed to enter these Shows, nor be allowed to be on the grounds. In addition, no aggression reinstatement procedures will be performed at these Shows.

"Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment."

HEART BY CARDIOLOGIST:

The heart auscultations are \$45 per dog and are performed by Dr Alyssa Pinkos, DVM, DACVIM. Please do not print out the form from OFA - there are special forms now that we will have at the clinic.

EYE BY OPHTHALMOLOGIST:

The eye examinations are \$40 per dog and are performed by Dr Adam King, DVM, MS, DACVO

THYROID BY MICHIGAN STATE UNIVERSITY:

This will be done by blood draw and submitted by us to MSU. The cost is \$85 per dog - BEST PRICE EVER!

BAER - BRAINSTEM AUDITORY EVOKED RESPONSE:

The BAER exam is \$85 and will be performed by Dr Joann Randall, DVM, DACT. NOTE: We need a minimum of 20 dogs in order to offer this test.

MICROCHIP - AKC REUNITE:

We will be implanting microchips with prepaid registrations from AKC Reunite. The cost is \$30.

PAW PRINT GENETICS DISEASE TESTING:

for our clinic, we have obtained special pricing with Paw Print Genetics. Any test that is offered on Pawprintgenetics.com is at a 30% discount. If you do 3 or more tests on one dog, your savings increases to 50%. Tests are normally \$80 each. At our clinic, each test is only \$56 (on multiple dogs). If you test one dog for 3 diseases, the cost becomes \$37.50 per test (Total \$112.50). The savings accumulates the more tests you do. (Ask me for the pricing breakdowns). We will collect the DNA ourselves (\$5 convenience fee per dog) and ship it to Paw Print Genetics - much less for you to think about!

OFA CLINIC DISCOUNT:

All OFA submissions will have a 50% discount over the regular submission price. Please print out your OFA forms (except HEART) for the all testing you're going to submit to OFA, so that we can apply the sticker.

The testing will be done at the Weitendorf Agricultural Education Center at 17840 W Laraway Rd, Joliet IL 60433 from 9am until 3 pm. Please follow the signs to the health clinic.

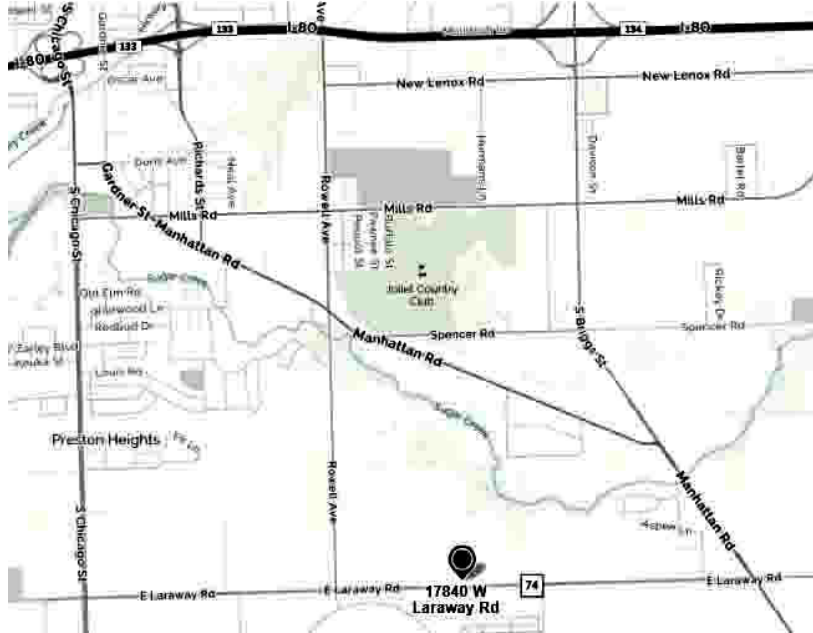

The list of Table and Ramp breeds can be found on the AKC Website under Conformation Judges - Announcements. Emergencies In emergency situations, with the approval of the Show Chair, breeds customarily examined on the ground may be examined on a ramp, not on a table. An emergency is defined as a temporary condition that arose immediately prior to or at a dog show. Convalescence from a medical procedure, illness and recuperation from injuries are examples of conditions that are not emergencies. The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

3. (Event Class) Consult the classification in this premium list. 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
